

## RECRUITMENT PRIVACY STATEMENT

Plus Property is committed to maintaining strict confidentiality in relation to personal information obtained during the recruitment process.

This Privacy Statement applies to any personal information you disclose to Plus Property through your use of our website, email address, job recruitment websites or postal address/office address ('sites').

By using these sites, you consent to our use of your personal information in accordance with this Privacy Statement.

Where used in this Privacy Statement, the terms "personal information", and "Australian Privacy Principle(s)" have the meaning attributed to those terms in the Privacy Act (Cth) 1988 ("Privacy Act"). Any reference to "Plus Property Employee", "we", "us" and "our" is a reference to Plus Property.

When you apply for a job with us, we collect and hold personal information about you which may include:

- information from your resume and cover letter – including your name, address, contact details, skills and other employment history details;
- academic transcripts or qualifications;
- referee details;
- information collected during the interview process;
- information collected through the reference check process;
- Health or medical information whether you have a disability in which we need to make any necessary adjustment during the recruitment process and employment;
- Work entitlement in Australia including any visa you hold;
- Police Check and Working With Children Check information; and
- Any other miscellaneous information that is disclosed by you.

This personal information will be held and stored in a secure location for the purposes of assessing your suitability to fill the specific vacancy for which you have applied, and for assessing your suitability for other vacant positions that may arise at a later date. We may also distribute the information internally to the relevant hiring managers involved in the particular recruitment activity. We will not disclose your personal information to a third party without your consent, except as required by law.

How will we keep your personal information safe?

- a. Plus Property takes all reasonable steps to ensure the security of our system and to protect your information from misuse, interference, and loss as well as unauthorised access, modification or disclosure.
- b. Any information which we hold for you is stored on secure servers in Australia.
- c. In addition, our employees and the contractors who provide services related to our information systems are obliged to respect the confidentiality and privacy of any personal information held by us. Except in the case of breaches of our obligations under the Privacy Act to protect your personal information, Plus Property will not be held responsible for events arising from unauthorised access of your personal information. In the event of a data breach, Plus Property is committed to comply in

all respects with the requirements of all Australian Privacy Laws including, the requirements of the Privacy Amendment (Notifiable Data Breaches) Act 2017 (Cth).

If you are the successful applicant your information will be retained in your Employee File.

If you are an unsuccessful applicant your information will be retained for a period of six months after which your information will be destroyed. You can request us to delete your information held by us at any time by contacting us.

We take all reasonable steps to ensure that your personal information is accurate, complete and up to date. Please contact us if your details have changed, if you believe that information we hold about you is incorrect, or if you have concerns about how we are handling your personal information.

## **Email alerts and other communications**

- a. Users may subscribe to receive emails regarding new employment or volunteer opportunities that match searches you have previously undertaken by providing Plus Property with your email address. Users can unsubscribe from such emails at any time by clicking on the unsubscribe link in the email.
- b. If you apply to an opportunity or you save a search, Plus Property may also provide you with selected information about employment or volunteer opportunities and related advice in email communications from time to time. Plus Property may also contact you by telephone. You agree that Plus Property may contact you about employment or volunteering opportunities. You may 'opt-out' of receiving emails from Plus Property by clicking 'unsubscribe' in the footer of an email received. When we speak to you over the phone, we may record the calls for training, verification and quality assurance purposes. Any Personal Information collected on those calls is used in accordance with this Privacy Statement.
- c. From time to time, we may contact you by email or phone in relation to your use of our Sites, new features and other employment or volunteer-related content.

## **Feedback and Complaints**

Plus Property welcomes ideas and feedback about all aspects concerning your privacy. Plus Property stores feedback that users send to us. This feedback may be used to administer and refine the service we provide.

If you have any complaints about our dealings with your personal information including any breaches by us of any Australian Privacy Principles or any questions regarding this Privacy Statement you are able to submit that complaint or query by contacting us using the methods detailed in the "Contact" paragraph below. Any complaints received by us will be referred to our compliance team for prompt investigation and a written response will be provided to you as soon as possible.
